### Membership Fees and Term

- Members must pay an **annual subscription fee**.
  - All fees must be paid by the due date to avoid suspension or termination of membership.
  - Every member undertakes to be liable for the sum not exceeding one pound (£1) whilst a member of the club and for 12 months after they cease to be a member
  - Fees are **non-refundable**
  - **Membership is for a 12month term unless otherwise stated, and can not be cancelled part way through the membership year**
  - **If a monthly payment plan is used via the Clubs chosen provider, this must not be cancelled by the member part way through a membership year. Should a member cancel their agreement, a cancellation fee will be payable by the member**
